Thank you for discussing the Used Oil Processing Facility Closing Cost Estimate Update with me for 2014. The strategy shall be to update the Surety Bond Rider, Performance Bond Number 1027381, originally effective on September 9, 2011 for the estimated amount of \$80,000. This cost estimate is based on the 2014 Cost and a five percent per year increase for the next six years. In doing so the Surety Bond Rider should last the entire Permit Cycle until 2020 before an updated renewal is necessary. This should ease Synergy's capability in acquiring a Performance Bond, given the same Bond amount will last an estimated five years (or entire permit cycle), and given the Performance Bond will not require an annual update.
