The Florida Department of Environmental Protection (the Department) has received and reviewed your Time Extension request dated May 05, 2015 through an email on May 05, 2015 to transfer Used Oil and Material Processing Facilities in Florida.

The review of the permit transfer applications indicate that they are incomplete and in non-compliance. Under paragraph 62-710.800(6)(a), Florida Administrative Code, “The owner or operator of a used oil processing facility shall provide the Department with proof of financial assurance issued in favor of the State of Florida in the amount of the closing cost estimate for the facility”.


Please provide the Financial Assurance Final Document information requested through emails dated March 04, 2015 and May 05, 2015 by Susan Eldredge, the Department’s Solid Waste Financial Coordinator, in Tallahassee, Florida.

Further action on processing your applications are temporarily held in abeyance pending receipt of your complete response. The Facility must submit the final documents no later than the approved due date of May 29, 2015.
