On 03/05/14 the Florida Department of Environmental Protection (the Department) received your notification that the above-referenced facility is no longer doing business as a Used-Oil Handler. Our records have been adjusted accordingly.

This letter is to inform you that effective immediately you are no longer authorized to transport, or market used oil, or used oil filters, or burn off-specification used oil, from this location, in the State of Florida. Handling used oil or used oil filters without a valid registration is a violation of the law, subject to penalty.
