Dear Mr. Nevin,

According to Department records, the most recent Used Oil Transporter (UOT) registration we have on file for your facility is dated 10/08/2014. Pursuant to subsection 62-710.500(2), Florida Administrative Code (F.A.C.), the UOT registration must be renewed annually by submitting the required documentation no later than March 01 of each year.

Since the Department did not receive the required documentation for your facility, your registration expired on June 30, 2015. Transporting UO without a valid registration is a violation of the law, subject to penalty.

This letter is to inform you that effective immediately you are no longer authorized to transport, or market used oil, or used oil filters, or burn off-specification used oil, from this location, in the State of Florida.
