Good morning Carrie,

As discussed with you earlier this week during a telephone conversation I am addressing the referenced facility's request for additional time to respond to the RAI to you concerning the due date for the requested information. The 14-days specified in the 3/1/2017 RAI would have a submittal date of 3/15. The facility respectfully requests a 37-day extension to that submittal due date. If approved by DEP the new submittal due date will be Friday 4/21/2017.

The additional time is needed to properly address the Department's comments and clarify matters as requested specific to the management of consumer products that are low explosives, closure cost estimates, etc., as well as to coordinate a solid waste intermediate permit modification for the addition of a non-hazardous waste shredder at this location so it can be incorporated into this RCRA

Part B permit modification.
