In order to do a change of location you will need to submit an 8700-12FL Florida Notification of Regulated Waste Activity (blank forms attached) for your old location; check the box "Final Notification" on the top of page 1 and fill out the form with all pertinent information, old Michigan EPA ID number, including item 11.B.(1) on page 2 "Facility Closed" "Closed at this location and moved or moving to another". Sign, date and mail to us at the address shown at the top of page 1 of the form. This will close your FL HWT registration at the old location. Then you will also need to submit the entire set of documents (8700 Form and HWT Certificate of Liability Insurance) for your new location. The 8700-12FL we just received will suffice, provided a new signature page with original WET signature is submitted. For the new location you will check the box "Initial Notification" at the top of page 1 of the 8700 Form. The Name of the Insurer must be listed exactly as it is registered. The ACORD form submitted lists 3 insurers, the Certificate of liability lists what I am sure is a broker, not the actual insurer.
