Good afternoon Ms. Dorwart,

Thank you for contacting us regarding our upcoming meeting on Friday, October 27, 2017 at 1:00pm at our District Office. Based upon the violations noted during the May 2017 compliance inspection (report attached), it is advised that you bring documentation to support that the violations have been corrected. Specifically:

- Verification of used oil transporter training for each employee for 2016 and 2017;
- Disposal receipts for the used oil that was being stored in T-43, which indicates the date and amount that was hauled off or alternatively, photographic evidence that shows that T-43 is now secondarily contained; and
- Proof that all used oil trucks are equipped with halogen monitoring devices or test kits.

Please let us know if you have any questions regarding the items needed to address the open violations.
