We want to thank you for your inspection of the Howco Ft Myers facility. Our management team has reviewed your inspection records. I want to ensure you that we will mend any violations that were noted in your report in a timely manner.

1. In response to the black sealant worn away and cracking in areas. A work order has been opened for resolution of this violation. We will be inspecting this area next week and will have this area resealed within 30 days. We have some projects we are finishing currently in St Pete and will have our maintenance personnel in Ft Myers immediately following completion of these projects. We will reseal all containment to ensure it is impervious to used oil and product.
2. Tank 3 and 4 will be labeled with words fully identifying the product inside. This will ensure there is no future confusion in case of emergency. Tank 3 will be labeled "Petroleum Product Water", and tank 4 will be labeled "Antifreeze".
3. All drivers will be retrained on acceptance and delivery record completion. We will instruct all drivers to sign all transfer manifests and records of any product being moved in and out of our facilities.
