NOTICE OF PROPOSED ISSUANCE OF AND TENTATIVE PUBLIC HEARING FOR A PERMIT  
UNDER THE RESOURCE CONSERVATION AND RECOVERY ACT

International Solvent Recovery, Inc., has applied to the Environmental Protection Agency (EPA) pursuant to 40 CFR Part 124 for a permit for a hazardous waste storage facility.

EPA proposes to issue a permit for the storage of hazardous waste to International Solvent Recovery, Inc., located at the Bartow Airport Industrial Park, Bartow, Florida. The permit is to be issued under the authority of the Resource Conservation and Recovery Act (RCRA). The facility has been assigned EPA identification number FLD980729610.

International Solvent Recovery, Inc., is in the business of recycling hazardous wastes from industrial sources. This permit will allow construction and operation of a storage facility to store hazardous wastes in up to 1584 (55 gallon) containers and 20 (6000 gallon) tanks. The permit conditions for construction and operation are tentative and open to comment from the public. ✓ 10 tanks

This is to notify the interested public of a tentative hearing on the proposed permit. If significant public interest is expressed in holding a hearing, then a public hearing will be held on July 18, 1983, at 7:00 p.m., at the Bartow Civic Center, 2250 Floral Avenue, Bartow, Florida.

The decision on whether there is significant public interest in holding the hearing will be based on the receipt of at least one written notice of opposition and a request for a public hearing. EPA reserves the right to cancel the public hearing if significant public interest in holding a hearing is not communicated to EPA by July 12, 1983. However, even if a hearing is not held, all written comments on the facility will still be considered by the agency in formulating a decision on issuing the permit. If persons wish to attend the hearing and have not requested that a hearing be held, they should call Mrs. Earlene Hanson at EPA, 404/881-3544, or Mr. Dick Powell at the Tampa District Florida Department of Environmental Regulation (FDER) office, 813/985-7402, prior to the hearing date to determine if the hearing will be held.

Copies of the information submitted by International Solvent Recovery, Inc., along with the statement of basis and draft hazardous waste storage permit, are available for public inspection (between the hours of 8:00 a.m. and 4:30 p.m., Monday through Friday) at the FDER district office located at 7601 Highway 301 North, Tampa, Florida (813/985-7402); the Tallahassee FDER office located at the Twin Towers Office Building, 2600 Blair Stone Road, Tallahassee, Florida (904/488-0300); the FDER district office located at 2020 State Road 60 East, Bartow, Florida (813/533-3203); and the U.S. EPA located at 345 Courtland Street, N.E., Atlanta, Georgia (404/881-3544).

A nominal fee for copying and/or mailing may be charged. Arrangements for copying should be made in advance.

A 45-day comment period begins May 27, 1983, and ends at midnight July 12, 1983. (Note: If the public hearing is held, the comment period will automatically be extended to the end of the hearing.) The comment period and the hearing are to provide an opportunity to comment upon the proposed issuance of a hazardous waste storage permit to International Solvent Recovery, Inc.

Persons wishing to request a public hearing or to comment upon the permit application or the proposed permit conditions should submit such requests or comments in writing. Requests for a public hearing or copies of comments regarding the Federal RCRA permit should be sent to the U.S. EPA, Attention: Earlene Hanson, at the above address.

All written and oral comments presented at the hearing (if it is held), and all written comments received by the agency during the public comment period, will be considered in the formulation of final determinations regarding the permit issuance. After consideration of all written comments and of the requirements and policies in RCRA and appropriate regulations, the EPA Regional Administrator will make the final decision regarding the permit issuance. The EPA Regional Administrator will notify all persons submitting written comments of the final permit decision. If the determinations are substantially changed, the EPA Regional Administrator will issue a public notice indicating the revised determinations.
