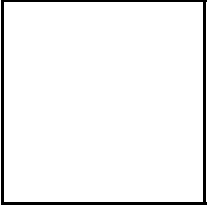

The Department has reviewed the referenced document for the groundwater sampling event from January 2017 – December 2017 Status report for the Former Cliff Berry, Inc. Port Everglades Facility. The Report indicates that the latest sampling event dated July 17, 2017, benzene and TPH analytes were below GCTLs in all the three groundwater wells (MW-1, MW-2 and MW-3). However, in groundwater wells, MW-1 and MW-3, Isopropyl-benzene analyte is above GCTLs. We accept the report for our records. The Department looks forward to the results from the next sampling event report for 2018, which is due by December 31, 2018.
