Tammy,

Thank you for providing the revised Attachment 6; it has been inserted into the PDF RAI responses document.

After discussing the review comment [(5.d.(1))] provided in the RAI letter, the intent of the comment was to clarify the discrepancy between the list of hurricane supplies (page 38) and the list of initial response equipment (page 13-14). Both lists appeared to have basically the same content.

As discussed over the phone, the equipment list from section 4.7 of the SPCC was not included in the responses but was revised. The list of emergency equipment at the facility must be included with the contingency plan [per RAI comment 5.d.(2) and per the facility's permit (Part II.A.3)]. Please provide the updated equipment list either as a separate document or re-send an Attachment 5 that includes the list.
