Your permit for the referenced facility will expire on April 12, 2019. The renewal permit application is due 60 days prior to the expiration of the current permit. Therefore, the renewal permit application is due on or before February 11, 2019. If the application is not received by the due date, the permittee will not be considered in compliance if the time to issue a permit extends beyond the permit expiration date. A renewal Used Oil permit fee of \$2,000.00 and a renewal Solid Waste permit fee of \$1,000.00 must be submitted along with the renewal permit application(s).
