Hi Shannon,

Thanks for returning my call. I visited the Clean Harbors Bartow facility a while back and they listed you as there FDEP Hazardous Waste Inspector. The folks at Clean Harbors provided me with copies of recent inspection reports (most recent May 4, 2018 – no violations), including the 2017 inspection involving USEPA that resulted in a consent order. I just had a couple questions:

- Is it correct that FDEP conducts annual hazardous waste inspections?  
DEP conducts inspections in accordance with our memorandum of agreement with USEPA, usually annually or at least once every two years. There was an annual inspection requirement for TSDFs accepting CERCLA waste, but I believe that has been dropped from the workplan.
- Have all issues from prior inspections been resolved to the satisfaction of FDEP? No pending issues.
- How would you characterize the relationship of the facility with FDEP and their response to FDEP requests/concerns? Very cooperative.
- Are you aware of any public complaints or concerns relative to the facility? Details if so. No complaints/concerns.
