### ATTACHMENT September 13, 2005

- 1. The existing permit lists WRI's EPA identification number incorrectly. WRI should ensure that the correct identification number FLR 000 069 062 is included in the application for renewal of the permit. The EPA ID Number FLD 101 877 876 is for DLAC/WRI LLC (the RCRA Closure Site). Additionally, WRI should review all manifests, documents and other related items to ensure that the correct EPA identification number is listed.
- 2. At the time of the last CEI, WRI was accepting used oil filters from various off-site locations. WRI was not registered as a used oil filter transfer facility. This was in violation of Rule 62-710.850 (4), Florida Administrative Code (F.A.C.) and Specific Condition Part III (2) of permit number 79677-002-HO. Subsequent to the inspection, WRI notified the Department that they are operating a used oil filter transfer facility. WRI should update the facility operation description to include this activity.
- 3. There may be some additional changes to the permit which WRI suggested as a result of the August 9, 2004 CEI findings. We could not find any of these changes in our file. WRI may have a record of such proposed changes. Please provide these changes.
- 4. DEP has sent a letter dated August 26, 2005 requesting the facility to submit the closure cost estimates with respect to Rule 62-710.800. Please provide the detailed closure cost estimates and proof of financial assurance. This must be provided within 60 days after approval of cost estimates by the Department.
