Your permits for the referenced facility will expire on August 30, 2020. The renewal permit applications are due 60 days prior to the expiration of the current permits. Therefore, the renewal permit applications are due on or before June 30, 2020. If the applications are not received by the due date, the permittee will not be considered in compliance if the time to issue a permit extends beyond the permit expiration date. A renewal Used Oil permit fee of \$2,000.00 and a renewal Solid Waste permit fee of \$1,000.00 must be submitted along with the renewal permit applications.
