Our records indicate we did not receive all the required documents to process your HWT registration renewal. Transporting hazardous waste without proper registration is a violation of the law, subject to penalty. In reviewing your recent submittal, we noticed additional information is needed. The submitted ACORD form must exactly match the Certificate of Liability Insurance form we have on file. The policy number does not match. Please submit the following by Thursday, February 1st to continue processing your insurance update (see attached blank form for your convenience): 1 Certificate of Liability Insurance Hazardous Waste Transporter and Used Oil Handler form. The documents submitted must be signed (original 2WET2 signature) by an authorized agent of the insurance provider on file with the Florida Office of Insurance Regulation.
