This inspection was performed to ensure that the phase 2, fill area 4 with a footprint of approximately 5.40 acres was constructed in accordance with approved plans and specifications. The permittee had submitted to the Department an application for the minor modification of the permit along with the certification of construction completion for the phase 2, fill area 4 construction on November 19, 2009.

The permittee, site manager along with their consultant were present during the inspection. A walkthrough of the fill area 4 was performed. During this inspection limits of waste markers along with the signs denoting the edge of the waste along the fill area 4 boundary were in place. An additional berm to the west of the currently permitted fill area 4 berm was also located. Photos taken during the site visit are included with this inspection report.
