RUOH	09/16/2021	Email sent to Byron Jones: In reviewing your submittal, we noticed additional information is needed. The Insurance form submitted does not have an original wet signature and Insurer name is incorrect (see attached). The Name of the Insurer, as listed on the form is not registered with the Florida Department of Insurance website http://www.flair.com/companysearch . The Name of the Insurer must be listed exactly as it is registered. UO transporters are required to provide an Insurance form for the automobile liability inclusive of pollution liability. However, in the event your policies are separate then we will need you to submit two separate Insurance forms. Please submit the following by Thursday, October 7, 2021 to continue updating our database (see attached blank forms for your convenience): Revised Combined HWT/UO Certificate of Liability Insurance form for automobile and pollution liability. NOTE: Transporting used oil without a valid registration is a violation of the law, subject to penalties. As soon as possible, please mail the required form(s) with original hand signed signature to: DEP Waste Management Division-HWRS, MS4560 2600 Blair Stone Rd. Tallahassee, FL 32399-2400.
