The purpose of this letter is to provide notice that the permit numbered 00192423-007-HO and 00192423-008-SO will expire on April 22, 2022. Prior to Sixty (60) calendar days before the expiration of these permits, a complete application for the renewal of the permits shall be submitted on forms and in a manner prescribed by the Department and as stated in your permit. A complete application is due by February 22, 2022.

accompanying the appropriate permit fee of \$2,000.00 and \$1,000.00, respectively. The permit application and the fees to:

The renewal fees may also be submitted electronically. However, if the Permittee intends to submit the renewal fees electronically, the Permittee shall obtain instructions from the Department on how to submit the renewal fees electronically prior to attempting such submittal, and shall follow such instructions in making the electronic fees submittal.
