A complete application is due by February 16, 2022.

The application shall meet the fee requirements of Rule 62-4.050, Rule 62-710.800(4), Rule 62-730 and Rule 62-701.900(4), F.A.C. The Permittee shall submit a copy of the cover letter

accompanying the appropriate permit fee of \$2,000.00 and \$1,000.00, respectively. The permit application and the fees to:

The renewal fees may also be submitted electronically. However, if the Permittee intends to submit the renewal fees electronically, the Permittee shall obtain instructions from the Department on how to submit the renewal fees electronically prior to attempting such submittal, and shall follow such instructions in making the electronic fees submittal.

Since the permit application is due on February 16, 2022, please make arrangements as soon as possible if a pre-application meeting is required.
