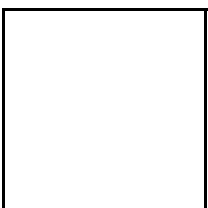

Thank you for your application for a Used Oil & Material Processing Operating Permits Renewal for the above referenced Facility. A Department staff review of the application submitted on April 15, 2022, indicates the application is incomplete. Pursuant to the provisions of Rule 62-710.800, Florida Administrative Code (F.A.C.) and Chapter 403.722, Florida Statutes (F.S.), all processing of the application is suspended when a permit application is deemed incomplete. Please provide the information listed below and refer to this correspondence in your response.

1. Used Oil Processing Facility Permit Application: Please submit complete application, Part I through Part II, including all Attachments, Pages 1 through 9, Originals with hard copies (Refer DEP Form 62-710.901(6), incorporated in Rule 62-710-800(3), F.A.C., Effective Date 12/2019).
2. Application to Construct, Operate, Or Modify a Waste Processing Facility: Please submit complete application including all Sections from A through C, Pages 1 through 4, Originals with hard copies (Refer DEP Form 72-701.900(4), F.A.C., Effective Date February 15, 2015).
3. Please include documentation of all changes or modifications that have been made at the facility in the last five years including Contingency Plan, Emergency Response Plan, SPCC Plan, Training, Closure Plan, Closure Cost Estimates, Facility Site Plan and Tank Table in the revised permit application.
4. Please provide Facility Site Plan (8.5”X11”) and Tank Table (8.5”X11”) in word document in order for us to insert them into the renewal permit.

General Comment: “Voluntarily provide a brief history and description of any environmental enforcement actions taken by the Department, delegated local program, or federal agency against the applicant and provide a history of any reported releases or spills by the applicant within the past five (5) years.”

In order for the Department to continue processing your application, please submit the information requested as soon as possible, and refer to this correspondence in your response. The response must be signed, sealed, and dated by a registered Florida Professional Engineer. The Department must receive a response within 60 days of the date of this letter, or June 26, 2022, unless a written request for additional time to provide the requested information is submitted and approved. Pursuant to subsection 62-730.220(6), F.A.C. and Section 120.60, F.S., failure of an applicant to provide the timely requested information by the applicable deadline may result in denial of the application.
