However, in the event your policies are separate then we will need you to submit two separate Insurance forms. Please submit the following by Tuesday, June 28, 2022 to continue updating our database (see attached blank forms for your convenience): Revised Combined HWT/UO Certificate of Liability Insurance form for automobile and pollution liability and Correct the EPA ID number for the Fort Myers facility 2 FLR000213629. NOTE: Transporting used oil without a valid registration is a violation of the law, subject to penalties. As soon as possible, please mail the required form(s) with original hand signed signature to: DEP Waste Management Division-HWRS, MS4560 2600 Blair Stone Rd. Tallahassee, FL 32399-2400.
