The purpose of this letter is to provide notice that the permit numbers 71815-017-HO and 72815-018-SO will expire on November 20, 2022. Prior to sixty (60) calendar days before the expiration of these permits, a complete application for the renewal of the permits shall be submitted on forms and in a manner prescribed by the Department and as stated in your permits. A complete application is due by September 20, 2022.

The application shall meet the fee requirements of Rule 62-4.050, Rule 62-710.800(4), Rule 62-701.900(4) and Rule 62-730, F.A.C. The Permittee shall submit a copy of the cover letter accompanying the appropriate permit fee of \$2,000.00 and \$1,000.00, for Used Oil and Solid Waste, respectively. The permit applications and the fees to:

The renewal fees may also be submitted electronically. However, if the Permittee intends to submit the renewal fees electronically, the Permittee shall obtain instructions from the Department on how to submit the renewal fees electronically prior to attempting such submittal and shall follow such instructions in making the electronic fees submittal.

Since the permit application is due on September 20, 2022, please make arrangements as soon as possible if a pre-application meeting is required.
