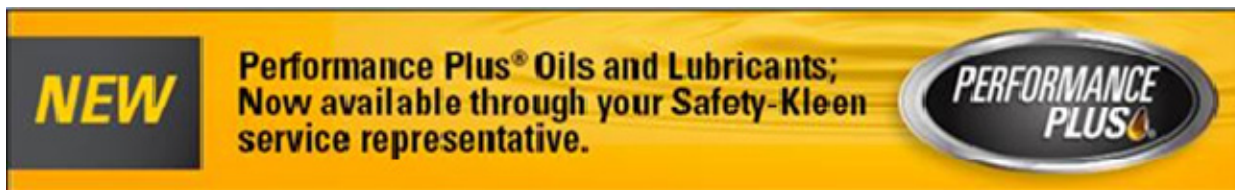

I hope you are having a good week.

Attached are pictures of the labels we have replaced on the tanks where they had fallen off. We will be doing some maintenance on the tanks over the next few week to address the rusted surfaces from peeling paint, while we are searching for a contractor to repaint all the tanks. I have also included a picture of the painted over Solid Waste label on the roll off that inaccurately had dual labels.

The remaining items you noted during our walk through are currently in progress:

- The used oil filters that had been temporarily placed into the mix pit are being moved daily to the oil filter crushing system in the main warehouse. We anticipate clearing all filters out of the pit and processing them in the oil filter crusher system by 2/28/2022. I will send you a photo of this area when this is completed.
- Tank farm secondary containment floor/walls – peeling paint/sealant. The first part of this project will be for us to pressure wash the tank farm containment area; this will be completed within the next two weeks. We have already compiled a list of equipment and materials needed for painting/sealing the area, and are ready to place the orders. Provided there are no supply chain issues in obtaining the needed materials for this project, I estimate we can have it completed by mid-April though we will do everything possible to finish earlier.
