**Introduction:**

Diversified Marine Tech, Inc. (DMT) was inspected by the Florida Department of Environmental Protection (Department) on January 4, 2022, to determine the facility's compliance with state and federal regulations regarding used oil. Diversified Environmental Services, Inc. (DES), a co-located sister company, was inspected at the same time. The facility initially notified as a Large Quantity Generator of Hazardous Waste as DES on September 27, 1990, under the name Elk River Corporation. The facility re-notified as a non-handler of hazardous waste on December 17, 1992. On April 13, 2010, the facility name was changed to DMT and on June 22, 2010, the facility registered as a Used Oil and Used Oil Filter Transporter.

Both DMT and DES are currently registered with the Department as used oil transporters and transfer facilities. Neither company has a permit for used oil processing, nor do either of the companies market used oil fuel or hazardous waste. All oil is shipped to off-site facilities for additional processing and marketing. The facility was previously inspected by the Department on May 24, 2021. Gerry McCormick Jr., President, assisted Department personnel throughout the inspection.

**Process Description:**

DMT provides ship maintenance services and repairs and operates out of the Port of Tampa, with a full-service wet berth system in place. The facility previously used a dry docking system which is no longer in service. DMT currently has 3 employees. DMT operates Monday through Friday, from 7:30 AM to 4 PM, and occasionally will continue services until 7:30 PM. The facility uses the City of Tampa's water and sewer services.

Eight frac tanks are staged at DMT for storing oily waste, two tanks were rentals from Alder Tank Rentals and the remaining six are owned by DMT. Only one frac tank contained used oil at the time of the inspection. Oily wastewater is transferred to trucks or tankers for transport to the DES facility for further treatment. At the time of the inspection, the DES 800 barge and DES 1625 barge, used to transport oily waste, were on-site but are no longer in use. Sewage pumped from ship holding tanks is taken directly to the City of Tampa's Howard F. Curran

### Records

- Used oil is not stored at DMT for longer than 35 days; the facility uses an Excel Tracking Sheet to ensure that this timeframe is not exceeded.
- Three years worth of oil delivery records were available for review at the time of the inspection. The records included the EPA identification numbers of both companies. Records also included designated signatures and dates.
- Employee training records were up to date. The training is conducted annually, taking place at the end of January. DMT uses a third-party entity to fulfill essential training needs.
- The facility's Used Oil Transporter/Transfer Facility Registration is current through June 30, 2023. DMT's insurance/financial assurance is current and adequate.

### Conclusion:

At the time of the inspection, Diversified Marine Tech, Inc. was operating in compliance with state and federal regulations regarding used oil.
