Hi Ashley,

I have heard back from our Tallahassee folks and there is no provision in either the federal or state rules that allows for a time extension to store hazardous waste for greater than 10 days at a transfer facility.

As the transporter, Daniel's Health is required to follow the requirements for compliance with the manifest in 40 CFR 263.21, where the transporter must deliver the entire quantity of hazardous waste which he or she has accepted from a generator or a transporter to: (1) The designated facility listed on the manifest; or (2) The alternate designated facility, if the hazardous waste cannot be delivered to the designated facility because of an emergency prevents delivery; or (3) The next designated transporter; or (4) The place outside the United States designated by the generator.

Hi Michael

I am looking to speak to someone to see if there are options for an extension to a 10 day hazardous waste transfer facility registration that we have.

Our primary hazardous waste incinerator suffered a fire shortly before the holiday. They are going to be out for an extended period of time. After reaching out to other hazardous pharmaceutical waste incinerators to see if they have the ability to handle the waste, but the industry capacity issues prevent them from accepting any additional waste.

We service hospitals in the area and we are working with our generators to maximize on-site storage space and accumulation times based on their generator status.

There have been a couple that generate a significant volume of waste that exceeds their ability to store waste safely on-site and they are considered about safety, compliance, and public health issues. I am just looking to explore whether we could get an extension of our 10 day time limit in an effort to support in dire cases.

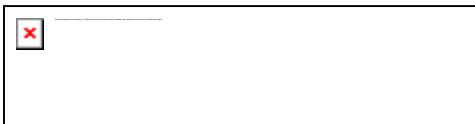
