## Dear Mr. Lakhlani:

The Department has completed its review of the Facility Closure Report for January Environmental's Used Oil and Material Processing facility located at 1820 State Road 60 West in Bartow, Florida 33830. The Facility Closure Report was found to be in adherence with the Department approved Closure Plan dated February 7, 2023 and meets the requirements of the Final Consent Order No. 23-0013, executed on February 7, 2023. The Facility Closure Report addresses the requirements for a Used Oil Closure Plan under Chapter 62-710, Florida Administrative Code (F.A.C.).

During the implementation of the Facility's Closure Plan, soil sampling at the proposed SB-9 location was not conducted. While the Department concurs with the justification provided in the Facility Closure Report for not sampling SB-9, in the future, notification to the Department is required prior to any deviations of an approved plan.

Based on a review of the soil and surface water samples provided, all samples were below Residential Soil Cleanup Target Levels (SCTL) and Fresh Water Cleanup Target Levels (FWCTL), respectively.

Therefore, the facility is closed in a manner that minimizes or eliminates, to the extent necessary to protect human health and the environment, escape of hazardous waste, hazardous waste constituents, hazardous waste decomposition products, contaminated leachate or run-off to the groundwater, surface water, or to the atmosphere.

Also, please update your facility 8700-12FL, Form, as appropriate to surrender the facility site I.D. To release the Financial Assurance, a request will need to be made to the Financial Assurance Working Group.
