The Florida DEP does not consider the current application to be a complete application in support of the activities described therein at this time.

Your application makes reference to a poured concrete foundation with its own secondary containment for the area that is annotated on pages [1/384, 89-90/384] and the installation of three self-contained, prefabricated, flammable storage units. Additional secondary containment for new asphalt & concrete [2/384, 70/384, 89-91/384] to create an impervious surface to park trailers that contain hazardous, non-hazardous and oily waste is also being proposed. The foundation and secondary containment you are proposing is considered construction and will require a construction permit pursuant to Subsection 62-730.250(5), F.A.C.

If Triumvirate plans on proceeding with the described construction activities, you must amend your current application to include an application for a construction permit pursuant to Rule 62-730.250, F.A.C., and provide the additional information described in Subsection 62-730.250(1), F.A.C. An additional permit application fee of \$5,000.00 would be required with your updated application. Note, the Department has reviewed Attachment I.A. of the Permit Renewal Application dated May 1, 2023, and has determined the proposed activities are in compliance with the siting criteria of 403.7211, F.S.
