Annual compliance inspection scheduled by email on 6/24/2024 with Maryjane Faircloth. Current registration is available. Registration information checked with facility contact. Current insurance documents D & P are available. Monthly inspections detailed and accurately reflect conditions found during inspection. Missing one or two months. Site plan, SWAP data and photos reviewed in FIRST.

Inspected 1 double wall steel tank; Tremont- sub base Gen tank (EQ-228) with dry Morrison fig 517 3.5 gallon spill containment. Rochester inventory gauge, manual overfill procedures and manual interstitial monitoring. Tank Interstitial is dry. Anti-siphon protection provided by piping configuration above tank fuel level. Regular and emergency venting on primary tank. Emergency venting on secondary basin. Tank contents identified. System needs touchup painting for corrosion protection.
