Introduction:

On November 17, 2023, Wanda Robles, Florida Department of Environmental Protection (FDEP or Department) conducted a compliance inspection at Alta Construction Equipment Florida LLC (ACEF or Facility), located at 9601 Boggy Creek Road, Orlando, Florida for compliance with State and Federal used oil transporter requirements. The facility most recently notified the Department on June 23, 2019, and was originally issued EPA ID FLR000097378 on March 24, 2015. Alta Construction Equipment Florida LLC is a registered used oil transporter and transfer facility and used oil filter transporter and transfer facility. The current registration expires on June 30, 2024.

The facility employs approximately 40 employees, and operation hours are 7:00 AM to 5:00 PM Monday to Friday. One site representative was Mr. John Whitsell, Operation Manager.

INSPECTION HISTORY

The facility was inspected by the Department on October 23, 2019, under the previous name Flagler Construction Equipment

Process Description:

Alta Construction Equipment Florida LLC, facility sells, leases, and services heavy equipment. Equipment is serviced onsite and offsite locations. Offsite services only include oil changes, any other services are performed at the facility. As per the Operation Manager when they are going off-site for PM the transporter doesn't do multiple sites and never exceeds 55 gallons of used oil on services at any one time.

Used oil filters are stored in a 2-yard dumpster that was properly labeled "Used Oil Filters" and closed. The dumpster was located outside the building.

Used oil is stored in a double-walled tank that was properly labeled "Used Oil" and closed. The tank was located outside the building in secondary containment.

Records

Used oil and used oil filters are picked up by Safety Kleen. Records of pickups were being maintained onsite and contained all the requirements.

Used oil and used oil filter handlers annual report for 2022 was received in a timely manner.

The certificate of liability insurance on file with the Department expires on April 1, 2024.

Conclusion:

Alta Construction Equipment Florida LLC was inspected on November 17, 2023, for compliance with state and federal regulations, and based on the information provided during the inspection, the facility was determined to be in compliance with the Department's rules and regulations. Because the service company is handling shipments of used oil totaling 55 gallons or less from the generation site to a used oil aggregation point or collection center, the activity would not be regulated under the Subpart E standards for used oil transporters and transfer facilities. As we read the exemptions in 279.40 "Applicability" to exempt self-transporters from meeting any of the requirements in Subpart E: 279.40(a)(3) - This subpart does not apply to generators who transport shipments of used oil totaling 55 gallons or less from the generator to a used oil aggregation point owned or operated by the same generator as specified in § 279.24(b).
