**Introduction:**

On March 11, 2024, Carly Cogburn and Gina Laddick, Florida Department of Environmental Protection (FDEP or Department) inspected Tank Wizards Incorporated (Tank Wizards or Facility) for compliance with state and federal used oil and used oil filter regulations. The Facility was represented by Wendall Stroderd, Owner.

Tank Wizards first notified the Department as a used oil transporter, used oil transfer facility, used oil filter transporter, and used oil filter transfer facility on July 9, 2014, and received EPA Identification number FLR000210542. The Facility most recently notified the Department on February 14, 2024, as a used a used oil transporter, used oil transfer facility, used oil filter transporter, and used oil filter transfer facility and maintains EPA Identification number FLR000210542.

Tank Wizards leases the properties located at 7619 Coral Drive, West Melbourne, Florida, 32904 and 7607 Coral Drive, West Melbourne, Florida, 32904. Both properties are used for equipment and fleet storage.

**Inspection History (Past 5 years)**

The Facility was inspected in 2020 as a used oil transporter, used oil transfer facility, used oil filter transporter, and used oil filter transfer facility and no potential violations were observed at that time.

**Process Description:**

The Facility does not actively transport or transfer used oil or used oil filters but retains used oil and used oil filter registration with the Department to meet county requirements. Tank Wizards performs installation of fuel tanks, removal of fuel tanks, cleaning of fuel tanks, and polishing oil at external locations. Fuel polishing includes using a spectrum microbicide to clean the fuel and filtering the fuel through separators to remove contaminants and water as needed.

The Facility does not service their own fleet.

At the time of the inspection, there was no used oil or used oil filters on site.

**Records**

The 2023 Annual Used Oil and Used Oil Filter Handler Report was submitted to the Department on February 14, 2024, and was reviewed.

The Facility has insurance with an expiration date of July 2, 2024.

No training records were reviewed as the Facility does not actively transport or transfer used oil or used oil filters.

Note: Prior to transporting used oil or used oil filters, training must be provided.

**Conclusion:**

Tank Wizards Incorporated was inspected on March 11, 2024, for compliance with state and federal used oil and used oil filter regulations and was determined to be in compliance.
