Please submit the following by Wednesday, July 3, 2024 to continue updating our database (see attached blank forms for your convenience): Combined HWT/UO Certificate of Liability Insurance form for automobile and pollution liability with original (wet) signature. NOTE: Transporting used oil without a valid registration is a violation of the law, subject to penalties.
