Please submit the following by Wednesday, June 19, 2024 to continue processing your UO renewal registration (see attached blank forms for your convenience): updated Combined HWT/UO Certificate of Liability Insurance form for automobile and pollution liability (also list Jacksonville facility on Insurance form), Registration fee of \$100 made payable to Florida Department of Environmental Protection via check or money order, and 2023 Annual Report (even if it's "zeros"). NOTE: Transporting used oil without a valid registration is a violation of the law, subject to penalties. As soon as possible, please mail the required form(s) with original signature to: DEP Waste Management Division-HWRS, MS4560 2600 Blair Stone Rd. Tallahassee, FL 32399-2400.
