This email serves as an Exit Interview for the Routine Compliance Evaluation Inspection (CEI) conducted at your facility ECO Services DBR Inc located at 1901 NW 22nd St, Pompano Beach, FL 33069 on 01/28/2025. The Department would like to thank you for your time and cooperation during the inspection. We truly appreciate it.

As discussed during our visit, the Department is requesting documentation to facilitate the completion of the inspection report. Please provide the following by **02/14/2025**:

- What types of facilities does ECO Services DBR service?
- Used oil acceptance and delivery records for the years 2022, 2023, 2024, and 2025 for the months June, July, August per 40 CFR 279.46(a) and 40 CFR 279.46(b), respectively.
 - Given that 2025 has just started, please provide all acceptance and delivery records from the year 2025.
- Training records on used oil handling for facility personnel who handle used oil transportation and handling for the years 2022, 2023, and 2024 per Rule 62-710.600(2)(c) F.A.C.
 - Inspectors were informed that the only facility personnel who handled used oil handling is an individual named "David Bautista".
- Photo documentation of the DOT number of the truck transporting used oil per 40
 CFR 279.22(b).
- Halogen testing records from the years 2022, 2023, 2024, and 2025 per 40 CFR 279.44(a).
 - Given that 2025 has just started, please provide all halogen testing records from the year 2025.
- At the time of inspection, of the 15 used oil filters containers, 10 of the containers were not labeled "Used Oil Filters". Please provide photo documentation of the 10 containers labeled "Used Oil Filters" per Rule 62-710.850(5)(a) F.A.C.
- Inspectors also observed a stack of five 5-gallon buckets and one metal container that appear to have used oil residue. What are these containers used for? If they are used to catch used oil from the truck, then please provide photo

documentation of these 6 containers labeled "Used Oil" per 40 CFR 279.22(c)(1) and Rule 62.710.401(6) F.A.C.

At the time of inspection, representatives informed inspectors that the final designated facility refuses used oil deliveries when their facility is at capacity. As a best management practice, it is recommended for ECO Services DBR to document the refusals.
