Good morning,

Thank you for reaching out, I apologize for my late reply. I have attached an 8700 Form, if you could please fill out the highlighted areas and return to me via email. I will process the form and send it to our Tallahassee office. After discussion with my management team we determined that your activities require you to register as a Used Oil Transporter, Used Oil Transfer Station and VSQG. Once we receive this form there will be no additional necessary actions associated with my inspection.

Your facility falls under 40 CFR 279.1: *Used oil transfer facility*

- Any transportation related facility including loading docks, parking areas, storage areas and other areas where shipments of used oil are held for more than 24 hours and **not longer than 35 days** during the normal course of transportation or prior to an activity performed pursuant to [§ 279.20\(b\)\(2\)](#). Transfer facilities that store used oil for more than 35 days are subject to regulation under [subpart F of this part](#).

Please be aware that if any used oil is stored at your site for longer than 35 days an additional permit will be necessary. As we discussed onsite, please continue to dispose on a regular monthly basis and retain all records of disposal at your site.
