WASTE TIRE ANNUAL REPORT

October 1, 2009 through September 30, 2010

BACKGROUND

In response to the Solid Waste Management Act (The Act), the Lena Road Landfill Solid Waste Management Facility was designated a waste tire collection and storage site by the Florida Department of Environmental Protection. As is set forth in The Act, whole tires are segregated at our Solid Waste Management Facility.

PROGRAM OPERATIONS

Code Enforcement Officers respond to complaints of illegal dumping of tires within the County. Monitoring of illegal sites is conducted to ensure that violations are resolved by the property owner. The Manatee County Utilities Department reports on an as-requested basis to the Florida Department of Environmental Protection regarding the location of illegal tire dump sites, the number of tires on each site, and applicable comments as to cleanup efforts that are underway. In addition, the Public Works Department routinely collects tires from County roadways or ditches for transport to the waste tire site.

The following are methods of informing Manatee County residents how to properly dispose of waste tires. The "How To Guide" is handed out and billing inserts are mailed to County residents in their utility bills yearly informing them of proper disposal and contact information for questions. This information is also included on the Manatee County website.

The following tonnages were reported entering the Lena road Landfill Solid Waste Management Facility from October 1, 2009 to September 30, 2010:
