We reviewed the referenced inspection report and provide this letter in response to selected items and/or concerns expressed by the Department. The format of this letter response is to list the applicable portion of the Department's observation with our response immediately following.

Rule: 62-701.530(2)(c) 1.

> Explanation: Following a post inspection file review, it appears that gas monitoring results for the first quarter 2011 gas sampling event have not been submitted.

Corrective Action: Please provide information on the status of these results.

Response: The gas sampling event was included in Attachment 4 of the First Semiannual 2011 report, dated May 5, 2011. A copy of the gas sampling report is attached.

Comment: 06/09/11 inspection - A response from the facility was received 03/31/2011. It stated that "test pits" were dug to verify cover thickness and proposed that the observed waste was a function of equipment tracking. This violation refers to exposed waste observed during an inspection. The thickness of cover in an area of exposed waste is not in question: if waste was visible then cover is inadequate. Please verify that any and all exposed waste has been addressed as this is the performance measure of any type of cover.

Response: Maintenance has already been performed on the initial cover and conditions identified in the 03/31/2011 inspection report. Additional soil cover was applied to areas to cover waste materials.
