**RINKER MATERIALS CORPORATION-WASTE TIRE PROCESSING FACILITY
REQUEST FOR ADDITIONAL INFORMATION # 1**

In order to complete the review of the referenced application pursuant to Section 403.087(4), Florida Statutes (FS), Chapter 62-701, Rules 62-4.055, and 62-4.070, F.A.C., an addendum to the application, which is in accordance with Rule 62-701.320, F.A.C. (Solid Waste Management Facility Permit Requirements, General), and Rule 62-711, F.A.C. (Waste Tire Rule) shall be submitted to this Department which addresses the following:

- 1) Plans and drawings shall be prepared and submitted per the requirements of Rule 62-701.320(7)(f), F.A.C. Specifically, the following deficiencies were noted:
 - a) The plot plan (Attachment A.2) of the permit application is not legible. Therefore submit a plot plan for the facility / boundary survey, signed and sealed by a Florida Professional Mapper and Surveyor that addresses the requirements of Part III (A) (2) listed in Form 62-701.900(23). The plan shall meet the minimum technical standards set forth by the Florida Board of Professional Land Surveyors and Mappers in Chapter 61G17-6, Florida Administrative Code (F.A.C.), under Section 472.027, F.S. The certified plan shall include a legal description and acreage contained within, the boundaries of the Subject Property, etc. The map scale shall not be greater than one (1) inch = 100 feet.
- 2) Item (B) (5) of the Engineering Report included with the permit application does not adequately address the storage requirements of Rule 62-711.540, F.A.C., which requires a description of how the operator will maintain compliance with each of the storage requirements of said Rule. Therefore, revise and resubmit Part (III) (B) (5) of the Engineering Report accordingly.
- 3) The permit application states that the emergency preparedness manual/contingency plan, fire safety survey, and the closing plan for the facility are on file with the Department. Include a statement in the permit application that the information on the referenced facility, which is currently on file with the Department, is still valid. Please reference each document/plan/report by name, date, and author.
- 4) Provide a history and description of any enforcement actions described in Rule 62-701.320(3), F.A.C., relating to solid waste management facilities in this state.

Be advised that:

- 5) All application content, format, and sequence shall be in accordance with Rule 62-701.320 (7), F.A.C.
- 6) All information submitted in response to this request for additional information must be submitted as a complete package. A minimum of four copies each of any plans, reports, and supporting information for the proposed construction, operation or closure of the facility shall be provided to the DERM.
- 7) All engineering plans, reports, and information supporting the application shall be compiled by the engineer of record who shall be responsible for assurance that all technical components have been prepared under the direction and supervision and signed and sealed by the professional registered in the State of Florida in each contributing technical discipline (Rule 62-701.320(6), F.A.C.).
