Kanishka Perera, P.E., of HDR Engineering, Inc. submitted on your behalf, “Response to First Request for Additional Information” The original permit application was dated December 6, 2011 and received by the Department on December 7, 2011. The additional information dated January 27, 2011 and received on January 30, 2011 has been reviewed. Your application for closure permit, DEP File Number SF64-0078767-028, is considered complete. The Department will make a final determination about the permit application no later than April 29, 2012.

A Closure Cost Estimating Form for Solid Waste Facilities, FDEP Form 62-701.900(28), was submitted by Kanishka Perera, P.E., of HDR Engineering, Inc., signed, sealed, and dated December 6, 2011 for Tomoka Farms Road Landfill – North Cell Phase I and South Cell Class I Landfill. The submittal was part of the Closure Permit Application.

The total approved financial assurance cost estimates for North Cell Phase I and South Cell are the following:


