The Department has reviewed the document “Attachment F, Updated North Cell Class I Landfill Closure and Long-Term Estimate” submitted as part of the document “FDEP Solid Waste Permit Application for the Operations of North Cell Class I Landfill,” dated December 12, 2012 (Permit Application No. SO64-0078767-030). The submittal was a detailed cost estimate of the closure and long-term care costs for the North Cell. The closing cost is estimated at \$9,856,868.81 and the long-term care cost for 30 years is estimated at \$5,318,214.66. The cost estimates are approved by the Department.
