The Department has reviewed the document "Attachment 4, Cost Estimate for Closure and Long-Term Care," dated May 20, 2013, and received as part of the response to the 2nd RAI, also dated May 20, 2013. The DEP Form 62-701.900(28) Closure Cost Estimating Form for Solid Waste Facilities was included and signed and sealed by Juan C. Guerra, P.E., of Guerra Development Corp. The closing cost is estimated at \$1,134,030.52. The long-term care cost estimate for 5 years is estimated at \$332,062.50. The cost estimates are approved by the Department.
