The Department has received the “Application for Transfer of Permit or Notification of Name Change.” The application was signed by you. The application was dated July 19, 2013 and received July 29, 2013. We have assigned Permit No. 0314658-002-WT-TO to the application.

The application is for the transfer of permittee for Rayan Used Wholesale Tire from Aziz Mounir to Rene Ahwal. The following item remains incomplete. Evaluation of your application will continue to be delayed until all the requested information has been received. Pursuant to Section 120.60(2), Florida Statutes, the Department may deny an application, if the applicant, after receiving timely notice, fails to correct errors and omissions, or supply additional information within a reasonable period of time. Accordingly, please provide the additional information within 30 days of the date you receive this letter. Submit one copy of the requested information to the Department and reference the above permit application number in your correspondence.

In order to complete the transfer of permittee application, the Department must receive proof of financial assurance from the new permittee. The Department has approved a cost estimate of \$30,000 on January 17, 2013. This amount will allow for a maximum of 20,000 waste tires to be on site at any one time (which includes used tires).

As the new permittee, you are required to secure a financial mechanism for \$30,000 prior to the Department issuing the transfer of ownership permit modification. The financial mechanism needs to be coordinated with our Tallahassee office. Financial responsibility arrangements for the facility for the approved amount are to be made with the Financial Coordinator, Susan
