This is to acknowledge receipt of additional information dated April 2008 (received April 21, 2008), prepared by A2L Technologies, Inc. in support of the application to renew the operation permit for a waste tire processing facility referred to as the Global Tire Recycling Waste Tire Processing Facility.

This letter constitutes notice that a permit will be required for your project pursuant to Chapter(s) 403, Florida Statutes.

Your application for a permit is incomplete. Please provide the information listed below promptly. Evaluation of your proposed project will be delayed until all requested information has been received.

GENERAL:

1. The requested information and comments below do not necessarily repeat the information submitted by the applicant. However, every effort has been made to concisely refer to the section, page, drawing detail number, etc. where the information has been presented in the original submittal.
2. Please submit **4 copies** of all requested information. Please specify if revised information is intended to supplement or replace previously submitted information. Please submit all revised plans and reports as a complete package. For revisions to the narrative reports, deletions may be struckthrough (~~struckthrough~~) and additions may be shaded shaded or similar notation method. This format will expedite the review process. Please include revision date on all revised pages.
3. Please provide a summary of all revisions to drawings, and indicate the revision on each of the applicable plan sheets. Please use a consistent numbering system for drawings. The information provided with the April 21, 2008 submittal was largely unresponsive to this request. It appears that little effort was made to verify that the referenced information was the most current permit information for the facility and remains valid based on the current and proposed operation of the facility. In several sections of the April 21st submittal, specific references are made to information previously provided that was subsequently modified in the 1998 application, modified as part of a 1999 permit modification application, and/or revised or replaced as part of the 2003 permit renewal application.

Please review the Department current files for the facility and the previous and current permits issued by the Department to determine which documents are part of the current permit record for the facility, verify that the information is accurate and representative of the current design and operation of the facility, and as appropriate, either provide updated or revised information, in accordance with the procedures specified in General Comments #2 and #3, copy and resubmit the previously provided information that is still current and valid, or provide specific references to previously submitted documents that you are requesting the Department to consider in support of this application, specifically identifying the parts of previously submitted documents in which the subject information was originally submitted (prepared by, date of preparation, date received by the Department, section, etc.). Along with the specific references, a statement from the engineer of record must be provided, which verifies and reaffirms that the referenced information is still valid. **The permitting supporting information will be reviewed in its entirety after receipt of this information.**

9. Section 3.2: The references provided in this section appear to inaccurately reference the most current permit documents for the facility. Please verify and revise the information provided in this section accordingly, based on your response to Comment #2 above.

10. Section 3.5:

a. Please verify that the operation descriptions in this section are consistent with the current permit documents for the facility, based on your response to Comment #2 above and revise this section, as appropriate.

b. The reference provided in this section appears to inaccurately reference the most current permit documents for the facility. Please verify and revise the information provided in this section accordingly, based on your response to Comment #2 above.

c. Please provide the supporting information, calculations, and/or assumptions utilized in support of the maximum storage quantity provided in this section.

b. Please revise the appropriate site plan for the facility to provide specific layout details (e.g. area dimensions, # of rows, tires per row, aisle widths, barricade locations, etc.) of Area F.

c. Please provide the supporting information, calculations, and/or assumptions utilized in support of the maximum storage quantity provided in this section.

13. Section 5.3:

a. Please revise the appropriate site plan to identify the area dimension of the "wire and fiber storage area, the maximum wire pile and fiber pile volumes in the storage area, and the number and size of wire and fiber roll-offs to be provided. Please revise the narrative in this section to be consistent with this information.

b. Please provide the supporting information, calculations, and/or assumptions utilized in support of the maximum storage quantity provided in this section.

Section 6 - Closure Plan (Rule 62-711.700(2), F.A.C.):

14. Section 1.0: Please specifically identify the "previous documents" that the Closure Plan is intending to replace and supersede.

15. Section 4.0: The information provided with the April 21, 2008 submittal **was largely unresponsive** to the comments in Steve Morgan's February 8, 2008 letter regarding financial assurance closure cost estimates. Section 7 - List of Submitted Drawings:

16. Figure A2L1 - Site Plan: The operational details and information provided on this figure are inconsistent with the currently permitted site plan for the facility. Please provide a revised site plan for the facility that included both the previously provided operation details and information that remain valid and the changes to the facility site plan proposed by this application.

17. Figure A2L2 - Storm Drainage Piping: The details and information provided on this figure appear to be inconsistent with the currently permitted stormwater drainage plans for the facility. Please provide a revised plan for the facility that included both the previously provided information that remain valid and the changes to the facility proposed by this application.





Susan,

These are some very informal draft ideas about Global Tire that I discussed with Roger before he left. Not sure who to pass this onto now, so I am sending you a copy and placing a copy in Roger's old cube somewhere with the application info..Thanks- Mel

Global Tire –

I discussed w/Roger including a few things in their new permit. Since he is gone now – I am going to place this with the application as a reminder for whomever gets the permit next.

1. There needs to be a schedule for how often they are required to clean the site. Every time we go, there is stuff all over the ground. There is nothing really in their permit that addresses this – besides residuals management (on their site plan, only referenced in permit). They have tire chips, fluff, wire residuals in minimal amounts all over the ground. They say they scrape it up as needed, I think something more specific is required for accountabilities sake – maybe even a check sheet? Additionally, they have oil/water separator Roger says, and I saw a SW catch drain that they say they clean randomly – again, Roger and I think they need schedule for this process.
2. Their permit references the site plan, but the plan is large and is not easily attached to permit. In the new permit – is there a way to list out residuals? Where they come from and where they go (ie. recycle, landfill, etc)
3. They are storing finished tire chips in bags in front parking lot – Mark at the site said this is addressed in new op plan/ permit submittal – Is it?
4. They are receiving returned product from other people and storing it on ground – some of these chips were colored. They say the throw it back in system. There should be an additional storage place listed on their plan AND permit – ie not outside.
5. De-rimmer maintenance – oil dry on ground – nothing really addresses the cleaning of this area or the storage of the waste oil dry.

However, the information included in this section is identical to that which was submitted previously (dated 1/15/2003). Please revise the information to reflect the maximum storage quantities that you are requesting.

f. Certification -Part IV.A: A review of the State of Florida Corporate records indicates that Mark Bailey is not listed as an officer or registered agent of Global Tire Recycling of Sumter County, Inc. Please provide a letter of authorization for Mark Bailey from a listed corporate officer, or submit a revised form listing a new applicant who is a corporate officer.

7. Front Parking Area: Please provide the maximum quantity, storage time, storage method of materials that will be stored and/or staged in this area.

8. Area F: Please explain how this outdoor storage and staging area for the temporary placement of incoming waste tires will be designated (e.g., barricade, lines marked on floor, etc.) for recognition by employees or external haulers.

9. Area J:

a. Please provide details of the "wire or fiber storage area" that will be located along this area.

b. Please provide the maximum quantity and timeframe for processed materials that will be stored in this area.

c. Please clarify what is meant by "A rolling trailer will be located in this area..." [Emphasis added]

10. Addendum To Waste Tire Processing Permit Application: The text provided makes reference to information that was either "updated" or remains the same. As this appears to be the same document that was presented to the Department in March 10, 2003, please revise this document to reflect the current changes to the facility. For example Part III.B.4(b) identifies the Planned Daily and Annual Throughput of the facility was based on 2002 numbers; Part III.B.6 the Emergency Preparedness Manual was updated on 11/20/02; Part III.B.7 identifies the most recent copy of the Fire Safety Survey was transmitted on 11/20/02; Etc.

a. Please provide the type, number of and maximum size of dumpsters and direct load trailers that will be used to temporarily store waste prior to off-site disposal.

b. Please clarify if the direct load trailers shown on the site plan are the same as the referenced rolling trailers that are mentioned in the Addendum to Operations Plan provided. If so, please revise either the drawing or the text to be consistent.

- c. Please provide a detail which shows how the temporary wire staging area will be contained.
13. Please provide as-built drawings which show the processing building details including equipment used for processing waste tires and drainage inside the building.
14. Please provide a drawing which shows the location of all drainage systems outside the facility.
15. The boundary and topographic survey was not signed and sealed. Please provide a boundary survey and topographic survey that is signed and sealed in accordance with Rule 62-701.320(7)(f)5, F.A.C.

Please respond by **March 24, 2008**, responding to all of the information requests and indicating when a response to any unanswered questions will be submitted. If the response will require longer than **the date noted above**, you should develop an alternate specific time table for the submission of the requested information for Department review and consideration. Pursuant to the provisions of Rule 62-4.055(1), F.A.C., if the Department does not receive a timely, complete response to this request for information the Department may issue a final order denying your application. A denial for lack of information or response will be unbiased as to the merits of the application. The applicant may reapply as soon as the requested information is available.


This letter is to acknowledge receipt of the cost estimates dated January 9, 2008 (received January 11, 2008) as Part III.D of the above referenced permit application, prepared by A2L Technologies, Inc. The cost estimates received January 11, 2008 are not approved. The following information is needed to fully evaluate the estimates submitted:

General Comments

1. Cost estimates provided as part of permit renewal shall be revised cost estimates, and cannot be based on previously approved cost estimates. These revised estimates must include information and calculations to support quantities provided and current third-party quotes to support unit costs provided. Revised cost estimates, supporting information and calculations, and copies of the supporting third-party quotes were not provided with the January 11, 2008 submittal.
2. Based on your response to the comments provided above, please provide revised Part III.D., signed sealed by the professional engineer preparing the cost estimates.

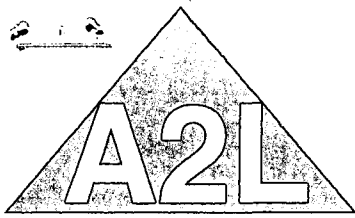

Included in the package are the Waste Tire Processing Facility Permit Application (DEP Form: 62-701.900(23)), a Site Plan with the proposed modifications, an Addendum of Operations Plan, and a check for \$1,250.00.

Pursuant to Part III - Attachments, facility design drawings (A) are included. Floor plan drawings have not changed since the previous submittal. Facility operations documents (B) have also not changed since the previous submittals, with the exception of the included Addendum and Site Plan. Pursuant to Section C, financial assurance information is included.

The modifications to the plan are all for storage and staging of materials to be processed or materials that have been processed. The modifications are made to make the movement of these materials easier and to make the storage and staging more manageable. 
