This report provides the analytical data from the monthly sampling event conducted at the SCLF on September 5, 2013. A hard copy of this report will be sent to your attention via the USPS. As required, the ADaPT files from this sampling event are also provided, and I have copied Clark Moore in Tallahassee on this e-mail. Of note, Test America again combined the IAMP samples with the effluent sample collected that same week in the Adapt files. The effluent (treated leachate) does not have a WACS ID number. We have asked Test America to not combine IAMP with any other samples collected at the site, and this issue has been resolved. The October sampling event report will have only the IAMP samples in the ADaPT files.
