The Department has completed the review of the certification of construction completion for Cell 10 construction at the J.E.D. Solid Waste Management Facility. The documents reviewed which describe the details of the Cell 10 construction include the following:

- "Final Certification Report, JED Cell 10 Construction," submitted by Brantley Engineering, LLC. The report was dated July 21, 2014. The Certification form was signed and sealed on July 21, 2014 by the Professional Engineer of Record, Allan S. Brantley, P.E. The report was received by the Department on July 22, 2014.
- "Cell 10 Leachate System Startup Reports," submitted on September 9, 2014.
- Email discussion and revised Figures 1 and 2 regarding clarifications to the Cell 10 certification report. Emails were sent and received between July 30, 2014 and August 1, 2014 and are available for review in Oculus as two separate documents.

Based upon the review of the above submittals, the site inspection on May 6, 2014 (inspection report was sent under separate cover on May 15, 2014), and the certification by the Professional Engineer of Record, the Department concurs that the construction of Cell 10 has been completed and is substantially consistent with plans and specifications approved in DEP Permit No. SC49-0199726-023. Financial assurance for Cell 10 has been demonstrated as documented by the Department on July 17, 2014. Therefore, as of the date of this letter, Cell 10 is hereby authorized for the acceptance of waste.
