I reviewed the documentation submitted to demonstrate financial assurance for the above referenced facility and find it is in order. Evergreen National Indemnity Company insurance certificate, dated April 12, 2010, identifying policy number 555249, demonstrates adequate financial assurance. As required by the Orange County Interlocal Agreement, the financial assurance covers the higher of the closing costs associated with the approved Orange County and Department of Environmental Protection estimates: \$111,828.30 for closing. Therefore, Taft Recycling, Inc. is in compliance with the financial assurance requirements of 40 CFR Part 264, Subpart H, as adopted by reference in Rule 62-701.630, Florida Administrative Code and the terms of the Orange County Interlocal Agreement, at this time.
