Your application for permit, DEP File Number 0297136-002-WT-02, is considered complete as of October 7, 2014. The original permit application and appropriate fee was received October 7, 2014. We will make every effort to issue our final agency action as quickly as possible.

The Department has reviewed the Closure Cost Estimating Form for Solid Waste Facilities, form 62-701.900(28), which was included in Attachment 8 of the Application. The Form was certified by Veronica Sgro, P.E., of Koogler & Associates, Inc. The closing cost was estimated at \$4,824.00, which was calculated as the permitted capacity of 80.4 tons of tires stored at the facility multiplied by the estimated disposal cost of \$60 per ton. The estimated disposal cost was provided by McGee Tire Company of Apopka Florida. The cost estimates are approved by the Department.

The most recent document received by the Department to demonstrate financial assurance was approved on October 9, 2014 for the amount of \$10,000. Please note, if the approved estimates include a decrease in either the closing or long term care amounts, this communication is **not** authorization to decrease that amount in the financial instrument.
