Thank you for the opportunity to comment upon your proposed Notice of Intent to Grant Variance and proposed Notice for Proposed Agency Action. While Manatee County would prefer to have a full two year variance, I understand the concerns of the Department of Environmental Regulation and believe that Manatee County will work with the Department under the proposed variance conditions.

I have two recommended changes in the Notice of Intent to Grant Variance and both occur on the first page. On line 10, I would like to insert the phrase "reconsider the request and" after the word "Department." Second, I would like to replace the word "gives" on that line with the phrase "modifies its prior notice and gives." These requested changes are primarily precautionary in the event of a possible appeal and are intended to emphasize the fact that this has been one continual process and not two or more different requests.

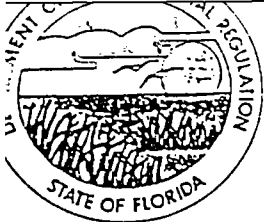
