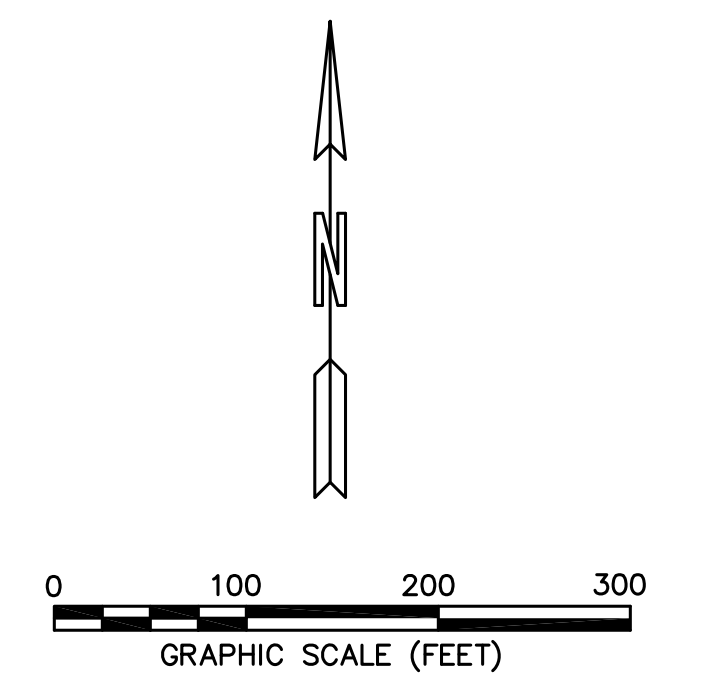
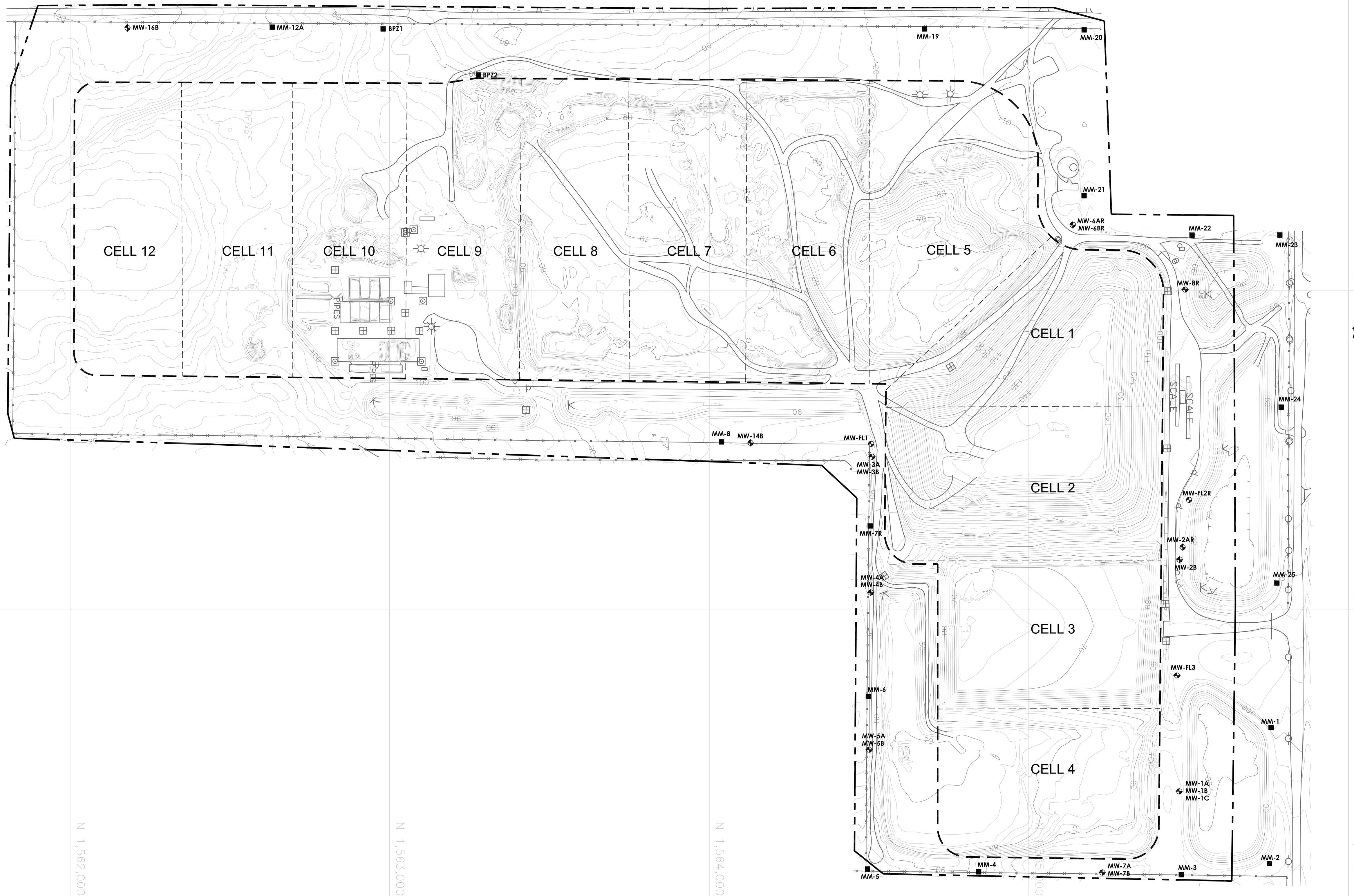
- Routine perimeter gas monitoring occurred on July 9, 2015.
