All –

The Department acknowledges the request to remove SW-1 as a surface water monitoring point submitted on July 9, 2015. The last request for removal of this sampling point (Class III Operation permit renewal dated 6/20/2014) resulted in the change from a compliance monitoring point to a background monitoring point. The change to SW-1 was done in order to observe what is coming in from off-site, and in this case, to observe the influence of the nearby highway (I-4). At this time, SW-1 will be kept as a background monitoring point for observation purposes only, especially with the newest results (May 2015 Semiannual Groundwater and Sampling and Monitoring Event) showing an increase in lead and mercury following the changes made to the pond by FDOT.
